ANNOUNCEMENT

This announcement is made pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on The Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”).

Reference is made to the announcements of Yuxing InfoTech Investment Holdings Limited (the “Company”) dated 18th December 2008, 13th January 2009, 11th August 2009, 22nd October 2009 and 27th October 2011 regarding the dispute over damages for infringement of interest in which Guangdong Jianlibao Group Company Limited (“JLB Group”) instituted legal proceedings against Mr. Zhu Wei Sha and the controlling shareholders, actual controller, directors, supervisors and senior management of Beijing Golden Yuxing Electronics and Technology Company Limited (“Golden Yuxing”) (the “Legal Proceeding”). As a result of the Legal Proceedings, on 20th October 2009, the Company was notified by Gongbujiangda Jiangnan Industrial Development Co., Ltd (“JI”) that the Intermediate People’s Court of Foshan, Guangdong Province has issued a Notice of Enforcement to JI on 4th September 2009, ordering JI to assist in freezing Golden Yuxing’s 36.66% equity interest in JI and its dividend entitlements and suspending the payment of dividends attributable to Golden Yuxing in respect of its equity interest in JI.

On 27th October 2011, the Company announced that it was notified by JI that the freezing period was extended from September of 2011 to September of 2012. The Company was recently notified by JI that the freezing period is further extended from September of 2012 to September of 2013 (the “Order”).

Other than the Order which is expected to affect the financial performance of the Company for the year ending 31st December 2012, the board of directors of the Company believes that the Legal Proceedings will not have any material impact on the daily operations of the Group.

The Company will make further announcement(s) to update the shareholders of the developments of the Legal Proceedings and the settlement negotiation with JLB Group as referred to in the Company’s announcement dated 29th June 2012.
