INTRODUCTION

The purpose of this circular is to provide you with information regarding resolutions to be proposed at the AGM which include, among other matters, the approval of the grant of the Issue Mandate and the Repurchase Mandate, the re-election of retiring Directors, and to give you notice of the AGM.

GENERAL MANDATES

At the AGM, resolutions will be proposed to approve, inter alia, the followings:

- (a) to grant to the Directors the Issue Mandate to exercise all the powers of the Company to allot, issue and otherwise deal with additional Shares up to a maximum of 20% of the aggregate number of the issued Shares as at the date of passing of such resolution:
- (b) to grant to the Directors the Repurchase Mandate to exercise all the powers of the Company to repurchase up to a maximum of 10% of the aggregate number of the issued Shares as at the date of passing of such resolution; and

RE-ELECTION OF RETIRING DIRECTORS

In accordance with Bye-law nos. 86(2) and 87(1) of the Bye-laws of the Company and Appendix 15 of the GEM Listing Rules, three Directors, Mr. Zhu Jiang, Ms. Shen Yan and Ms. Dong Hairong will retire at the Annual General Meeting and, being eligible, will offer themselves for re-election at the Annual General Meeting. Pursuant to the code provision A.4.3 of the Corporate Governance Code and Corporate Governance Report set out in Appendix 15 to the GEM Listing Rules, if an independent non-executive director serves more than 9 years, his further appointment should be subject to a separate resolution to be approved by shareholders. Ms. Shen Yan has been serving as an independent non-executive Director for more than nine years. The Company has received from Ms. Shen a confirmation of independence pursuant to Rule 5.09 of the GEM Listing Rules. The Board is of the opinion that Ms. Shen still maintains an independent view of the Company's affairs and is able to carry out his duties as an independent non-executive Director in an impartial manner. The Board therefore supports Ms. Shen to offer herself for re-election as an independent non-executive Director at the AGM.

This is an explanatory statement given to all Shareholders relating to the resolutions to be proposed at the AGM authorising the Repurchase Mandate. This explanatory statement contains all the information required pursuant to Rule 13.08 and other relevant provisions of the GEM Listing Rules.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company was 1,803,088,800 Shares.

Subject to the passing of the ordinary resolution granting the Repurchase Mandate and on the basis that there are no changes in the Company's issued and fully paid share capital from the Latest Practicable Date to the date of AGM, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 180,308,880 Shares.

2. REASONS FOR REPURCHASES

The Directors believe that it is in the best interest of the Company and its Shareholders as a whole for the Directors to have general authority from the Shareholders to enable the Company to repurchase Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share. Repurchases of Shares will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and Bye-laws and the applicable laws and regulations of Bermuda.

In the event that the proposed share repurchases were to be carried out in full at any time during the proposed repurchase period, there could be a material adverse impact on the working capital or gearing position of the Company as compared with the position disclosed in the audited consolidated financial statements contained in the annual report of the Company. 5. DIRECTORS, THEIR ASSOCIATES AND CONNECTED PERSONS

None of the Directors nor, to the best of their knowledge and belief having made all reasonable enquiries, any of their close associates (as defined in the GEM Listing Rules) has any present intention, in the event that the Repurchase Mandate is approved by the Shareholders, to sell Shares to the Company or its subsidiaries under the Repurchase Mandate.

Mr. Zhu Jiang, aged 61, graduated from Beijing University of Technology majoring in mechatronic engineering. Mr. Zhu has over 22 years of research experience in computer engineering, extensive experience in digital-to-analog circuits and high-level assembly languages programming and over 12 years of management experience. Mr. Zhu is a director and the legal representative of certain subsidiaries of the Company. Mr. Zhu was appointed to the Board as an executive Director on 24th July 2013.

Mr. Zhu has entered into a service contract with the Company for a term of three years commencing from 24th July 2013, which is renewed/automatically for successive terms of one year each commencing from the day next after the expiry of the then current term. Mr. Zhu's appointment is subject to retirement by rotation and re-election at the AGM pursuant to the Bye-laws.

Mr. Zhu is entitled to receive a remuneration of HKD2,329,000 per annum (including discretionary bonus, retirement scheme contribution and other benefits) subject to review by the remuneration committee of the Company.

Ms. Shen Yan ("Ms. Shen")

Ms. Shen Yan, aged 55, holds a bachelor's degree in accounting and has over 23 years of accounting experience and 20 years of auditing experience. Ms. Shen worked with Beijing Zhonggongxin Certified Public Accountants* (北京中公信會計師事務所), where she presided over audit works for local and international renowned enterprises in manufacturing, professional affairs and services and has accumulated solid experience in corporate finance management and auditing. Ms. Shen has successively held key positions in numerous corporations in the PRC and possesses good expertise in financial accounting, budgetary control and financial management. She also took part in the researches, editing and publication of books on financial management subjects. Ms. Shen had also been a staff of Beijing University of Technology. Currently, Ms. Shen is the financial controller of a PRC firm. Ms. Shen was appointed to the Board as an independent non-executive Director on 12th January 2005.
